INFORMATION FOR CONTRIBUTORS

Submission of manuscripts	<p>Manuscripts should be sent to HAEMA Journal, Kifisias str. 27, P.C 11523 Athens, Greece, tel: +30 210 7211806, fax: +30 210 6466288, e-mail: infohaema@eae.gr</p> <p>All manuscripts must be submitted in triplicate, including three complete sets of figures and tables, typewritten or printed, double-spaced with margins of at least 1.5 cm.</p> <p>Receipt of manuscript will be acknowledged with a letter indicating the manuscript number, which will be used for any future communication concerning the manuscript. All manuscripts will be reviewed by the Editor, the Associate Editors, members of the Editorial Review Board or other expert reviewers. Acceptance of papers will be decided in meetings of the restricted Editorial Board (Editors and Associate Editors) and authors will be notified by letter of the decision to accept, revise or reject the manuscript. Rejected papers will be returned to the authors. All material in HAEMA represents the opinions of the authors and does not reflect the opinions of the Hellenic Society of Haematology. Authors submitting manuscripts do so with the understanding that if accepted, copyright of the article shall be assigned exclusively to the Hellenic Society of Haematology and authors will be requested to sign a copyright release form.</p>
Manuscript organization	<p>Submitted manuscripts, accompanied by a cover letter with authors declaration that their material is original and not previously published/submitted elsewhere, should be in English (UK), typed double spaced on the one side of paper. Any special points should be emphasized in the covering letter from the main author. Papers should be structured as follows: (1) Title page, (2) Abstract, (3) Introduction, (4) Material and methods, (5) Results, (6) Discussion, (7) Acknowledgments, (8) References, (9) Tables and Figures, and (10) Table and Figure legends. Begin each manuscript component (title page, abstracts, etc.) on separate pages. The pages of the manuscript, beginning with the title page, should numbered consecutively.</p>
Title page	<p>The title page should contain an informative title, author's full names and name of departments(s) and institutions(s) to which the work should be attributed. Name, full postal address, telephone, fax numbers and e-mail of the corresponding author. A running title with no more than 40 characters must be supplied. Financial support should be acknowledged as a footnote of the title.</p>
Abstract and Key words	<p>The abstract should not exceed 250 words adequately described the work and highlight its significance. It should state the purpose of the study, basic procedures (study subjects/patients/animals and methods), main findings (specific data and statistical significance), and principal conclusions. Avoid to use abbreviations and citations. Below the abstract, provide 3-10 key words that will assist indexers in cross-indexing the article, using terms from the Medical Subjects Heading list from the Index Medicus whenever possible.</p>
Introduction	<p>Brief present of the background, giving only pertinent references. State the purpose of the article and summarize the rationale for the study. State the specific questions you want to answer. Abbreviations and contractions should be defined in the text when first used.</p>
Material and methods	<p>Describe selection of patients or experimental animals, including controls. Patient's names or hospital numbers should be avoided. Studies involving human subjects must include details of age, origin, and person's sex. Investigations in patients and volunteers must indicate that acceptable measures have been taken to obtain informed consent. Patients must be identified by number or serial letter and not by initial or names. Where patient's photographs are used, the faces must be masked (authors must obtain consent from patients for photograph used). Identify study population with the criteria used for inclusion and/or exclusion, methods, apparatus (manufacturer's name and address), and procedures in sufficient details to allow other workers to reproduce the results. Give references and brief descriptions of methods that have been published. Identify drugs and chemicals, including generic name(s), dosage and administration route(s) at their first appearance in the text, avoid using non-standard abbreviations. Author must indicate that the procedures were approved by the Ethical Committee of Human Experimentation in their country and are in accordance with the Helsinki Declaration of 1975. All papers reporting experiments using animals must include a statement in the Material and methods section giving assurance that all animals received humane care. The rationale and methods</p>

for statistical analyses are also required. The authors accept full responsibility for the accuracy of the whole content, including findings, citations, quotations and references contained in the manuscript.

Results	Present results in logical sequence in text, tables and illustrations. In the text, explain, emphasize or summarize the most important observations. Do not repeat in the text all the data in the tables or figures, emphasizing only important observations. Units of measurements should be expressed in accordance with SI units.
Discussion/ Conclusions	Do not repeat in detail data given in the Results section. Emphasize the new and important aspects of the study. Relate the observation to other relevant studies. Where appropriate Results and Discussion may be combined. On the basis of your findings (and others') discuss possible implications/conclusions. Link the conclusions with the goals of the study, avoiding uncertain statements and conclusions non supported by the work data.
Acknowledgements	Acknowledge only persons who have made substantive contribution to the study.
References	References must be included in numerical order at the end of the article according to the order of citation in the text. Include all authors names for papers up to six authors; for papers with more than six authors, only the first three should be quoted followed by et al. Complete article titles should be provided and first and last page for each reference. Journal titles should be abbreviated according to titles listed in Index Medicus. Abstracts and letters must be identified as such. Papers in press may be included in the list of references; work which has not been accepted for publication, work that is in preparation or personal communications should not appear in the reference list. Tables	Tables should be numbered consecutively with Arabic numerals. Type each table on a separate sheet, and provide clear descriptive titles.
Figures	All figures should clarify the text and their numbers be kept to a minimum. Details must be large enough to retain their clarity after reduction in size. Submit three copies of each illustration, identifying them with a label on the back which indicates the number, author's name and the top edge. Magnifications should be indicated in the legends. Line drawings should be professionally drafted.
Legends	Legends (brief and specific) should be typed in consecutive order on a separate page.
Proofs	Proofs are sent electronically as e-mail attachment to the corresponding author together with the Copyright assignment form which must be signed by the first author. The proofs plus any minor necessary corrections must be returned by fax or post to the Editor-in-Chief within 48 hours of receipt. Corrections should be written clearly in the margin of the text.
Copyright assignment	Contributors to HAEMA are requested to transfer to the Hellenic Society of Haematology the copyright of their contribution. By agreeing to this letter, they assign to HSH, in consideration of agreeing to publish your contribution, the copyright in our contribution in all media throughout the world for the full term of the copyright. They may publish figures or other parts of the contribution, without asking permission, in connection with any other work, provided that they make the usual acknowledgement when so doing.
Manuscript on disc	Authors of accepted manuscripts are strongly urged to submit these in final form in disc, to expedite publication.
